New Business- Gus Pehl mentioned that a blood drive is being held at the American legion hall November 19, 2007.

Gus also discussed the evangelization drive that Msgr. Enda has started, which reaches out to those in need and that have gone away from the church The next meeting is Nov. 26 in the cafeteria. Gus presented a sign up form for those interested.

The parish is looking for help with the St. Vincent Society adopt-a-family program that has been run by Jim Chude. All the different organizations have been asked by Msgr. Enda to support this program. Jim is looking for help on contacting the adopt-a-family's and finding out there needs. Chuck Hollis is the contact for Adopt-a-family at 990-0972.

The December 12 get together will be our Christmas party, there will be no business meeting. Gus asked for suggestions for the meal. Steve Montgomery suggested that we provide cold cuts and motioned that we charge \$5.00 for each family. Motioned passed. Steve M. will get the cold cuts and sides, Jim Jarreau offered to donate the bread. The society will provide drinks. Bring the family.

The Community Thanksgiving Dinner at St. Mary's is coming up, Darin Holmes has asked if the Society would support the turkey dinner. The society motioned and the vote passed that we would donate \$100.00 to the Community Thanksgiving Dinner.

Old Business- The Feast Day Barbecue is set for April 13, 2007. Rainey said that committees will be formed the first of the year.

Don Stevens spoke about the dues rate for the Society. The board recommends a rate of \$24.00 per year. Don motioned that the Society raise the yearly dues to \$24.00. Motion seconded. Committee Reports – Rental Policy Committee – The new rental policy has been put into effect for new rentals, rentals previously contracted are on the old policy. Building Facilities and Fixtures Committee- John Eilers reported on the building inspection; there are electrical issues that will be taken care of; Jeff Dittmar and Pat Kunz will address the chair storage; The upstairs bathrooms are being converted to storage rooms. The Knights will use one of the new storage rooms. The basement is to be cleaned up and made available for card parties and such.
