Reports:

Minutes – Wade Boone asked if there were any amendments or corrections to the May minutes which were mailed, emailed, and posted on the St. Joseph's Society website. There were none. The minutes stand approved.

Treasurer's Report – Darin Holmes reported the Profit and Loss for May, 2014: <u>Income:</u> \$25,371.98; <u>Expenses:</u> -\$6192.52; <u>Net Income:</u> \$19,179.46. He reminded the members that if anyone has questions about his report to contact him. The report was approved as presented.

Election Committee: Jimmy Lukacs stated that as of now the Election Committee has a possible slate of members to run for office this fall. The committee wants input from members, to clarify just what we are looking for in the next board of officers. He hopes to have an open forum at the September meeting to nominate a strong list of potential officers, hopefully 2 people running for each office.
