- 3. **Report on Barbeque Event held April 10th:** by Jimmy Lukacs and Darin Holmes. **Total plates served** 685;

Total Income: \$17,785.00; **Total Expenses**: \$1,867.93;

Net Income: \$15,917.07. A 16.7% increase over last year.
